# Facts about COVID-19 vaccines

# Vaccines (shots) are one of the tools we have to fight the COVID-19 pandemic.



To stop this pandemic, we need to use all of our prevention tools. Vaccines are one of the most effective tools to protect your health and prevent disease. Vaccines work with your body's natural defenses so **your body will be ready to fight the virus**, if you are exposed (also called immunity). Other steps, like wearing a mask that covers your nose and mouth and staying at least 6 feet away from other people you don't live with, also help stop the spread of COVID-19.

Studies show that COVID-19 vaccines are very effective at keeping you from getting COVID-19. Experts also think that getting a COVID-19 vaccine may help keep you from getting seriously ill even if you do get COVID-19. These vaccines cannot give you the disease itself.

#### A Message from Chief Dr. Ogletree Richardson

Our Tribal leaders are committed to making every effort possible to keep our Tribal citizens informed of events and activities that make a difference in the lives of our people. As we continue to work in the midst of the pandemic, we believe brighter days are ahead. We are thankful for our Tribal staff, school staff and volunteer Tribal citizens for their efforts to help our Tribe move forward. This message is not inclusive of all events and activities that have taken place or in progress. However, I will address the following items in this article:

Saponi Village: In 2017, The Haliwa-Saponi Indian Tribe embarked on a journey to build its first housing project, Saponi Village, located on Capps Farm Road. The Tribe secured a loan from the North Carolina Housing Finance Agency (NCHFA) to build the affordable housing units for our community. The loan application and approval process took about a year to complete. In April 2018, a Blessing of the Ground Ceremony was held to begin construction. Saponi Village includes two duplexes with



four separate living quarters. In December 2020, tenants moved into their new homes. This building project will be used as a stepping stone to move forward to provide more housing in our area. To build the housing project, a 30-year loan was provided by NCHFA. This is a forgivable loan, as long as we maintain the units in accordance with our commitments specified in the loan. During the process, NCHFA will monitor all properties and reports on compliance. The journey seemed to be long, but the Tribe successfully built its first affordable housing development project. The wait was worth it. Initially, we planned to hold a Ribbon Cutting/Open House Ceremony upon completion of the project. When we are able to operate with some normalcy, a ceremony will be held.

- COVID-19 Testing-Tribe: Our Tribal Administrator is working with the Halifax County Health Department to schedule COVID-19 drive-through testing at our Tribal Government Complex. The Tribe Sponsored Free Testing on Saturday, January 9 and SET a record for number of tests provided by Rural Health Group in the entire county ever in one day at 244 tests and with 34 positives. Plans are being made to schedule another Test Day on Saturday, February 6, 2021; however, the details are not available at this time.
- COVID-19 Vaccinations-School: Our School Administrator is working with the Warren County Health Department on the dates and locations for receiving the vaccine for the COVID-19 virus. If I receive additional details, I will share them with you.
- COVID-19 Vaccinations: On Wednesday, January 6, I received the COVID-19 vaccination, and at this time I have not experienced any side effects. Other Tribal leaders and members have informed me that they have taken the shot. Our goal is stopping the spread and rid our Tribal nation of this deadly virus.

COVID-19 Vaccination Site: The Warren County Health Department began vaccinating citizens who are 65 years and older on January 19, 2021. If you are interested, you may call the Warren County Health Department at 252-257-1185 to make an appointment.

Federal Recognition Update: Attorney Joshua Richardson has joined our team to assist with our Federal Recognition efforts. As Legal Counsel, his services are provided to us on a pro bono (no charge) basis.

Haliwa-Saponi Arcola Fire Chief: Congratulations to Mr. Dudley Lynch, the first Haliwa-Saponi Chief of the Arcola Fire Department. Dudley is the son of the late Raleigh and Claudese Lynch, married to Julie Moore Lynch, and father of three sons: Nicholas Dean Richardson, Dudley Lynch Jr., and Jakob Lynch. He received the promotion on December 30, 2020. Dudley is a former Haliwa-Saponi Tribal Council Member.

#### Veterans Memorial Project: An update will be provided on the Veterans Memorial Project at a later date.

Please take a moment to go by Saponi Village located on Capps Farm Road. We are proud of the hard work and persistence that our staff provided to make this project become a dream come true for us. Please take a moment to let our Tribal staff, school staff, and Tribal citizens who are volunteers know that their work is greatly appreciated. The Tribal Council played a major role in the decision-making process and is proud of the work that is being done by the staff and volunteers.

As Chief of the Tribe, I will once again make a plea to my people. Please do your part to be safe while this deadly virus is among us. We appreciate your support as Council, Tribal staff, school staff and Tribal citizens continue to work for the best interests of our Tribal citizens.


