April 13th, 2024


In an effort to tell our story at the AMERICA 250th anniversary event that will occur in 2026, we, the Magazine Spring ad hoc committee are

*Christian Buffaloe Wins RCS U.S. Kickboxing Featherweight

Christian Buffaloe, Kyokushin Karate fighter and instructor, recently won the RCS U.S. Kick-boxing Featherweight Championship title in northern Virginia on March 2nd. Buffaloe's match was a highlight of the entire event that was also broadcasted live on PayPerView TV.

Christian Buffaloe fought a very dominant match despite several low blows (four in the 1st round alone) from his opponent Amir Kane of Delaware. Buffaloe recovered and continued to fight a hard match winning an unanimous judges decision (30 - 26 from all 3 judges) and becoming the new Kickboxing Featherweight champion.

Christian Buffaloe is very appreciative to everyone for their support and interest. Many Haliwa-Saponi Indian tribal members were in attendance at the fight and this gave him great encouragement and motivation. Buffaloe is looking forward to the next challenge and plans to go back to Japan for more high level training this summer. Buffaloe is trained by Sensei Kenny Buffaloe, the official North Carolina Representative of Kyokushin Karate, and Kru Ken Armstrong of Virginia, a former Muay-Thai champion fighter in Thailand and Japan in the 1990's.

She is currently a graduate student at UNC Chapel Hill pursuing a Master of Arts in Teaching on the Elementary Education track. Zianne was involved with Carolina Indian Circle and serves on the Dean's Working Group on Global Indigeneity and the Haliwa-Saponi Tribe Bylaws Review Committee. She is also a member of Alpha Pi Omega Sorority, Inc. Zianne shared that "I seek to always be in community with my relatives, have conversations with tribal citizens from different nations, and always remember that cultural knowledge is a gift meant to be appreciated and shared, not taken for granted and guarded. The more we share space, knowledge, and love with one another, the more prosperous and sustainable the seeds of our people become."

HALIWA-SAPONI TRIBAL MEMBERS ATTEND NATIONAL AMERICAN INDIAN VETERAN CEREMONY

IN WASHINGTON, D.C.

At 4:00 am on March 14, 2024, six Haliwa-Saponi tribal representatives departed the Chief W. R. Richardson Tribal Government Complex to attend the National American Indian Veterans (NAIV) Charter "Signing Ceremony" at the Hart Senate Office Building in Washington, D.C. The six representatives attending the ceremony included: Chief Dr. Ogletree Richardson, Greg Richardson, National Commander for the NAIV and Executive Director for the NC Commission of Indian Affairs, Jewel Bissonnette, Pastor Al Cooper, Kim Silver (members of the Haliwa-Saponi Veterans Memorial Committee), and Mrs. Roena Daniel (widow of Navy veteran Purcell Daniel).

The Haliwa-Saponi Tribe has written and supported the advancement of this charter from its inception, and with the signing of the charter, the NAIV now has a larger platform to address tribal veterans' issues, to advocate for and serve the more than 140,000 Native American veterans living in the United States. As far as we know, we were the only "state-recognized" tribe in attendance to bear witness to and honor this historical occasion.

Senator Mike Rounds (R-S.D.) and Senator Ben Ray Lujan (D-N.M), lead the signing ceremony as the two senators who took up the effort to push the charter through Congress in 2021!

The signing ceremony marked the culmination of a 20-year battle, started in 2004 by the non-profit NAIV Organization, which was founded by its National Commander, (now 94 years old), Don Loudner, a Korean War veteran of the Cheyenne River Sioux Tribe in South Dakota.

This charter will provide more representation for American Indian veterans throughout the nation, who have been fighting for assistance largely through Veteran Administration claims and benefits, — something that has been lacking in and on tribal communities for decades.


